



## United States Space Force **Lineage and Honors History**

### **5 Space Operations Squadron (SpOC)**

**Lineage.** Constituted as 5 Satellite Control Squadron on 11 Apr 1989. Activated on 1 May 1989. Redesignated as 5 Space Operations Squadron on 30 Jan 1992. Inactivated on 31 Jul 1992. Activated on 22 Nov 1993. Inactivated on 13 Jun 2000. Unit was converted to a provisional unit, redesignated as 5 Expeditionary Space Operations Squadron and assigned to Air Force Space Command to activate or inactivate at any time on or after 5 Dec 2007. Activated on 4 Jan 2008. Changed status from a unit of United States Air Force armed force to a unit of United States Space Force armed force on 21 Oct 2020. Inactivated on 1 Jul 2023. Withdrawn from provisional status, redesignated as 5 Space Operations Squadron and returned to the DAF on 18 Jul 2023. Activated on 3 Jun 2024.

**Assignments.** 1000 Satellite Operations Group, 1 May 1989-31 Jul 1992. 50 Operations Group, 22 Nov 1993-13 Jun 2000. Air Force Space Command (later, Hq, United States Space Force; Space Operations Command), 5 Dec 2007-18 Jul 2023 (attached to Fourteenth Air Force [Air Forces Strategic-Space], 4 Jan 2008-1 Jul 2023). Space Delta 9, 3 Jun 2024-.

**Stations.** Fairchild AFB, WA, 1 May 1989–31 Jul 1992. Onizuka AFB (later, Onizuka AS), CA, 22 Nov 1993–13 Jun 2000. Shriever AFB (later, SFB), CO, 4 Jan 2008-1 Jul 2023. Joint Base Anacostia-Bolling, DC, 3 Jun 2024-.


